ABMI members act to tackle climate change as they subscribe to Science Based Targets Initiative and start a Sustainable Supply Chain Initiative

The global warming is posing a serious threat to the very survival of our planet.

At ABMI, member companies believe that everyone should play its part to reduce greenhouse gas emissions, moving away from single use, linear economy model. Therefore, ABMI members decided to subscribe to Science Based Targets Initiative and start a global Sustainable Supply Chain Initiative to ensure Sustainability of the total beverages' machinery supply chain.

"We are convinced that the moment to act is now: actions to prevent climate change effects cannot be delayed any further" says **Sam Strömerstén**, **President at ABMI**. "The Circular Economy Action Plan issued by the European commission will reduce pressure on natural resources and will create sustainable growth and jobs. As Association of European manufacturers of beverage machinery active in Europe, we feel the need to join forces and align on a common vision of how our industry should promote and advocate the shift to a circular economy. We want to take responsibility on ensuring we reduce our emissions in line with the latest climate science. We also believe that this cannot be decoupled from an in-depth investigation of our total supply chain, with the objective to lead it towards sustainable practices" declares Mr. Sam Strömerstén.

ABMI will issue recommendations to member companies on what to commit to in the contexts of different SBTi scenarios.

ABMI members decided to submit their carbon emission reduction targets to Science Based Targets Initiative.

Every ABMI member will be required to establish a greenhouse gas inventory, under the Association guidance.

Adherence to SBTi is a pivotal step in ABMI members' intention to contribute to Circular Economy communication, establishment and expansion with their know-how and technical solutions. They subscribed a newly defined Sustainability Charta, clearly indicating ABMI members vision and mission, and defined a common glossary encompassing sustainability terms and their meaning.

ABMI has also signed an agreement with EcoVadis to set up s Sustainability Supply Chain Initiative, which consists in assessing the suppliers of the various ABMI members on four sustainability themes: Environment, Labor & Human Rights, Ethics and Sustainable Procurement.

This will allow all members to enhance the sustainability of their suppliers thanks to the ability to benchmark and offer guidance for improvement.

ABMI members will also be welcome to join EcoVadis global network of over 90,000 rated companies and get rated themselves.

More information about SBTi (Science Based Targets Initative):

The SBTi is a partnership between CDP, the United Nations Global Compact, World Resources Institute (WRI) and the World Wildlife Fund (WWF). The SBTi call to action is one of the We Mean Business Coalition commitments.

Science-based targets show companies and financial institutions how much and how quickly they need to reduce their greenhouse gas (GHG) emissions to prevent the worst effects of climate change.
